
TULSA, Okla. — After vears of fighting to put land in trust status with the federal government, the Tahlequah-based United Keetoowah Band of Cherokee Indians has been given the green light to proceed with a trust application, according to a letter from Bureau of Indian Affairs Assistant Secretary Larry Echo Hawk.

But in the same letter. Echo Hawk reversed course on a decision issued last year stating that the Cherokee Nation is only a "suc-


