# Colorado River dispute leads to resort eviction

COLORADO Colorado River Indian tribal police showed up at Water Wheel Resort on Monday morning and evicted Bob Johnson, who has run the resort for 28 years.

Johnson locked himself in the resort's small convenience store when officers arrived.

After a brief standoff, Johnson reportedly agreed to a five-hour reprieve that gave him time to gather his belongings before leaving the premises.

The eviction is the latest chapter in a longrunning dispute between leaseholders along an approximately 20-mile section of the western banks of the Colorado River between Blythe and Parker. Some leaseholders believe the land on which they park their mobile homes is not part of the Colorado River Tribes Indian Reservation. Federal lawsuits have argued without success that decisions establishing the current boundaries were unlawful.

Many have not made payments for lease years. Johnson's lease ran out in 2008. In recent months, the tribe has issued trespass and eviction notices.

Johnson has a case currently before the U.S. 9th Circuit Court of Appeals challenging CRIT's authority over members. non-tribal Last Wednesday, the court declined to grant an injunction blocking his eviction.

CRIT Attorney General Eric Shepard said the tribal court met on Friday, via phone conference, and ordered the eviction. He wasn't sure if Johnson was part of the conference but said that Johnson's attorney was on the line.

Shepard said Monday that he had been fielding phone calls from concerned residents for much of the day.

"This is not an effort to evict or remove the tenants in the park," Shepard said. "The tribe would like the tenants to stay. We will need to negotiate new lease agreements. We don't anticipate rent increases.

In fact, Shepard said, little should change.

"I'll compliment Bob Johnson and say he did an admirable job of managing the park," he said. "It is a beautiful place. The tribe would like to keep it that way."

Cheryl Schmit has been an advocate for leaseholders on the west bank for years. She heads the advocacy group Stand Up For California.

"I can't believe the tribal court acted on a case that was before the Ninth Circuit," Schmit said. "Clearly it was a move on the part of CRIT that convolutes everybody's sense of justice."
