## Too late to prosecute transactions

AUBURN, Wash. — A Cayuga County judge ruled that it is too late to attempt to prosecute the Cayuga Indian Nation of New York for wholesale-level transactions of untaxed cigarettes.

Judge Mark Fandrich ruled on Thursday that Cayuga County District Attorney Jon Budelmann should have brought up the issue of wholesale level transactions during a series of civil litigation that lasted for nearly two years.

During that litigation, the state's highest court, the Court of Appeals, ultimately ruled that the Cayugaowned Lake Side Trading convenience stores in Union Springs and Seneca Falls are located on qualified reservations, and that the tribe cannot be prosecuted for possessing or selling untaxed cigarettes to non-tribe members.

The Court of Appeals also ruled that tribes, including the Cayugas, are required to collect taxes on cigarette transactions made to non-tribe members, but said the state failed to implement a system meant to collect those taxes.

Federal law exempts cigarette excise taxes from sales made between members of the same tribe.

On Thursday, Fandrich read from the Court of Appeal's 4-3 majority decision released last May, quoting a portion where the judges said it was undisputed that the tribe was conducting untaxed retail sales. but not wholesale sales.

### Riverhead doesn't want Indian casino By Vera Chinese North Shore Sun

ROCKY POINT, N.Y. Shinnecock Tribal Trustee Lance Gumbs said this week that although the Enterprise Park at Calverton had once been considered as a casino site, it is no longer at the top of the Shinnecock's list of possibilities.

"Riverhead has made no indication that it is actually interested," he said. "I think that is a big mistake on the part of the East End.'

Mr. Gumbs said feasibility studies are being conducted on sites in Brookhaven Town and Nassau County, though he declined to say exactly where. Tribal leaders said they prefer a site that's within commuting distance of the reservation.

Last Friday, the Shinnecock Indian Nation became the nation's 565th federally recognized tribe Friday afternoon, a step that paves the way for the tribe to build an Indian gaming facility on Long Island. The recognition became final Friday after the federal Interior Board of Indian Appeals dismissed objections filed on behalf of two groups, the Connecticut Coalition for Gambling Jobs and the Montauk Tribe, challenging the Shinnecock's pending federal recognition.

Mr. Gumbs said feasibility studies are being conducted on sites in Brookhaven Town and Nassau County, though he declined to say exactly where. Tribal leaders said they prefer a site that's within commuting distance of the reservation.

Fandrich added that

there was no mention of wholesale sales during two prior court hearings that discussed whether or not the county could file charges against the Cayu-

After reading his decision, Fandrich dismissed three sealed indictments filed against tribe employees and tribe members in December 2008.

Budelmann said those indictments were for possessing untaxed cigarettes and included evidence of wholesale transactions.
