Man who killed daughter sent to halfway house

SALT LAKE CITY — A man under federal supervision for killing his 3-month-old daughter in 2002 has been sentenced to serve time in a halfway house for violating the terms of his release from prison.

The violations by Redd Rock Serawop, 31, were related to alcohol use, according to Melodie Rydalch, spokeswoman for the U.S. Attorney's Office for Utah.

U.S. District Judge Dale A. Kimball on Tuesday sentenced Serawop to serve 180 days in the Cornell Community Corrections Center, a federal halfway house in

Salt Lake City.

Serawop inflicted fatal head injuries on his daughter, Beyonce, in November 2002 by throwing the infant on a bathroom floor while he was alone with her. He told investigators that the child, who was sick at the time, wouldn't stop crying.

"I was tired and upset and I threw her down," Serawop admitted in court records. "I believe her head hit the sink or the toilet."

The case was tried in federal court because Serawop is an enrolled member of the Northern Ute Indian Tribe and the crime occurred on the Uintah-Ouray

Serawop was initially convicted of voluntary manslaughter while within Indian Country in December 2003. That conviction was overturned after the 10th Circuit Court of Appeals in Denver ruled that the jury instructions in Serawop's initial trial failed to adequately differentiate between voluntary and involuntary manslaughter.

In December 2005, Serawop pleaded guilty to the same offense in exchange for a promise from prosecutors that they would reduce their sentencing recommendation by two years. He was sentenced in January 2006 to serve eight years in prison.

The Federal Bureau of Prisons website shows that Serawop was released from custody in May.

Tribal officials to testify at hearing

POLSON, Mont. — The assistant secretary of the Interior for Indian Affairs and the president of the National Congress of American Indians will be among the witnesses testifying at a field hearing of the U.S. Senate Indian Affairs Committee here Friday.

U.S. Sen. Jon Tester, D-Mont., a member of the committee, called the hearing to gather information on transportation issues in Indian Country.

The hearing is Friday at 2 p.m. at the Best Western KwaTaqNuk Resort.

Larry J. Echo Hawk, an assistant secretary of Interior, and Jefferson Keel, head of the National Congress of American Indians, will be among the first panelists.

The second panel will include E.T. "Bud" Moran, chairman of the Confederated Salish and Kootenai Tribes; James Steele Jr., chairman of the Montana-Wyoming Tribal Leaders Council; Timothy W. Rosette Sr., who works for the Environmental Health Division of the Chippewa-Cree Tribe of the Rocky Boy's Indian Reservation; and John P. Smith, transportation director of the Eastern Shoshone and Northern Arapaho Tribes of Wyoming.

Also testifying in Polson will be John R. Baxter, associate federal highways administrator at the U.S. Department of Transportation. He'll be accompanied by Robert Sparrow Jr., reservation roads program manager for the Federal Highways Administra-


