Ganienkeh slot machines reason tribe canceled deal

HOGANSBURG, N.Y. — Slot machines on the Ganienkeh territory in Altona, Clinton County, are the reason the St. Regis Mohawks have stopped sharing gaming revenues with the state, according to tribe member Raymond J. Cook.

Mohawk The Tribal Council announced last week that it no longer would share its gaming revenue with the state because the presence of other slot machines in the six-county area violates its exclusivity contract.

Council members had refused to say where the illegal slot machines are, other than mentioning Clinton County in

a letter sent to Gov. David A. Paterson's office.

the exclusivity," Mr. Cook said. "Apparently, patience ran out."

Mr. Cook said the state has known about the slots for years. The state has denied any knowledge of them, according to a letter delivered earlier this week from the governor's

The Mohawks at Ganienkeh do not belong to a federally recognized tribe, nor are the 5,700 acres they own a reservation. Instead, the state took the land into trust for Ganienkeh residents in the 1970s. It is not affiliated with the St. Regis Mohawks. The governor's office did

not respond to repeated calls requesting comment.

There are slots at the Ganienkeh Bingo Hall, according to an employee who would not give his name.

Members of the Ganienkeh "It's always been the state's People's Council declined to comment.
