

Oneida Tribe of Indians 'tribal icon' Purcell Powless dies at 84

HOBART, Ind. — Purcell Powless, a World War II veteran who led the Oneida Tribe of Indians for more than two decades, died Friday. He was 84.

A statement from the Native

"tribal icon," and said he passed away surrounded by family. Purcell was tribal chairman

from 1967 to 1990, a period during which the tribe's Ashwaubenon casino was built, generating significant prosperity for the Oneida people.

"Purcell leaves a legacy of American tribe called Powless a authority without great force,

integrity and respect built upon his honesty, and most of all love for his family, his people and his nation," the statement said.

Powless was born Christmas Day in 1925 and attended schools in Minnesota and South Dakota. He joined the Merchant Marines as a teenager during World War II and served three years.

He returned to Wisconsin and married Angeline Skenandore, with whom he raised eight children. She died in 2003.

Shortly after military service, Powless began a long career as a steelworker and at one time worked on the Sears Tower in Chicago.

In 1967, he was elected Onei-

da tribal chairman, a position that he would hold for 23 years, making him the longest-serving chairman in the tribe's history.

During his tenure, the tribe built the Oneida Bingo & Casino. In its statement, the tribe called the casino "a major financial boost" and said Powless "was successful in leading the tribe to


