Hollywood baffled by real-life crime drama

LOS ANGELES — In a world where people are paid handsomely to create make-believe drama that mimics real-life horror, the true-crime story of a Hollywood publicist killed by a fusillade of bullets as she drives home from a movie premiere has left her friends stunned and searching for a script that can somehow help them make sense of a senseless act.

Officials in Beverly Hills, where veteran publicist Ronnie Chasen was gunned down shortly after midnight Monday, have offered few theories about her death other than to say police believe someone opened fire on her late-model Mercedes from another vehicle.

But that hasn't stopped Chasen's friends in Hollywood's tightknit community of publicists and other behindthe-scenes people who help bring us the movies we watch from working overtime to develop their own theories:

Was Chasen's killing the result of a bungled carjacking by someone who stalked her through a rougher neighborhood until she reached a quiet Beverly Hills street? Or did Chasen, with fatigue setting in after attending a premiere and party for the movie "Burlesque," simply cut off the wrong person in traffic? "I'm not a detective, I'm a songwriter. But I can't see it being road rage," said Carol Connors, a two-time Oscar nominee who co-wrote the theme to "Rocky," and who was a friend of Chasen's for more than 30 years. Who would you really aggravate in traffic at that hour?" Connors asked, her voice breaking. "Maybe it was a gang thing and one of the initiations is to find a really pretty blonde lady in a really high-powered car and take her out." Laugh Factory nightclub owner Jamie Masada said Chasen's killing was the subject of dinner-table conversation when he met with TV executives earlier in the week. Others put forth road-rage theories, but he disagrees. "Maybe I'm watching too much television, but you see all those shows like '48 Hours' where someone hires a hit man to kill their wife," he said. "Maybe someone hired a hit man. He says, 'My wife drives a Mercedes, she comes by here.' And the hitman mistook her for his wife.'

worked with, and she was someone who met her demise way too early.'

Her relentless promotion of her clients, in a way several reporters described as pushy but never rude, was credited with creating the buzz that resulted in much Oscar, Grammy and Emmy recognition for them.

"Ronni was my very first publicist and paramount to the success of my career," said actor John Travolta.

On the night she died, Chasen had been working the premiere and after-party for the movie "Burlesque," trying to build Oscar buzz for its soundtrack and also getting a word in for an Oscar nomination for Michael Douglas' per-formance in "Wall formance in Street: Money Never Sleeps."

'She had called me five times in the past five days," said veteran Hollywood reporter Nikki Finke, who recalled she spoke with Chasen by phone for an hour that night, making small talk and hearing pitches for Douglas and "Bur-

lesque.' But despite that attitude, aggressive Chasen seemed to have no enemies, even among reporters she pestered.

'When it happened, when it was confirmed, I just burst into tears, said Finke.

That it happened in Beverly Hills — a city whose name is synonymous with wealth and where murders rarely occur — was all the

points to a professional hit. He discounted the Hollywood scenarios of gang-initiation killing, drive-by shooting or road rage.

Although street gangs from the neighboring Hollywood district have sometimes been a problem for Beverly Hills, he said, it's notable that no one in the multimilliondollar mansions that line the street where Chasen was killed heard a car speeding away.

"Typically, those guys step on the gas and they get the hell out of there,' he said.

Chasen was shot multiple times in the chest, at an intersection near a park where her killer could easily have hid in the bushes waiting for her, Foley said, adding that a partner following her could have alerted the shooter by phone to her approach.

"If she is the target and I am a bad guy, that is a great place for me to be," he said.

Afterward, Foley said, the killer could easily have fled quietly in a car, on a motorcycle or even on a bicycle.

That still leaves Chasen's friends with no end to the story, however. Why, they ask, would anyone do that to her?

"It just makes no sense whatsoever. It makes no sense. That's what nobody can understand," said publicist Kathie Berlin, a friend of 40 years.

"How do you go down a street in Beverly Hills that she's gone down a million times ... and you're shot dead?"

Judge tosses charge in alleged celebrity burglary

LOS ANGELES — A judge on Friday dismissed a felony burglary charge against a woman accused of breaking into Lindsay Lohan's home, saying there was insufficient evidence.

Los Angeles Superior Court Judge Larry Paul Fidler dismissed the count against Rachel Lee, who has been accused by authorities of being one of the masterminds behind a series of break-ins at stars' homes that netted millions in luxury clothes and goods.

The decision does not end Lee's legal troubles; she still faces a charge she broke into the home of reality TV star Audrina Patridge, and that she received a fur coat stolen from Lohan's home. She

also faces a conspiracy charge, along with four others charged with the burglaries.

Lee's attorney, Peter Korn, and prosecutor Chris Baker declined comment after the hearing

Baker had said authorities still hoped to turn up better evidence tying Lee, 20, to the Lohan burglary. Fidler said it appeared she was charged because she was the only Asian member of the so called "Bling Ring" and matched a vague description of one

of the Lohan burglars. "You have a nice receiving (charge)," Fidler said, "you don't have a burglary.'

The judge also expressed concerns about a statement given to police by another woman accused of the Lohan burglary in August 2009. Fidler questioned why the

20-year-old wasn't advised of her Miranda rights before speaking to police after her arrest in October 2009.

Baker argued that Tamayo was aware of her right to remain silent and had invoked the right several times before speaking with police. He said a Miranda warning was not necessary because Tamayo's attorney was

present for the interview, and did not raise any objections during the session.

Tamayo has challenged the admissibility of her statement that she was involved in the Lohan burglary, saying she was coerced into talking to police because she was threatened with deportation. She is an illegal immigrant.

Fidler deferred his ruling on whether Tamayo's statement will remain part

of the case, saying he wanted to hear testimony from one of the detectives accused of threatening her with deportation.

The judge is expected to rule when the case reconvenes on Jan. 14.

The rising Cumberland River wrecked just about every piece of equipment the country music superstar owned, from priceless vintage guitars to his favorite amps. He was scheduled to begin recording the tracks that would eventually become "Get Closer," and he wasn't sure if he should just scrap the whole thing until later.

"I think any musician will tell you: Give us something to make music with and we make music," Urban said. "It felt like we had some really good songs for this record. I felt really good about the songs. The band was ready. We had the studio booked. It wasn't that long ago I only owned one guitar anyway. I made a record with very few instruments in the beginning, so it was making the most of what we're given."

He borrowed a guitar from his guitar tech the first week and things went well enough that he decided to keep going. He added gear over the next few weeks, hitting eBay for a few guitars and amplifiers, and slowly expanded the sonic palette for the album. He used the first guitar he bought off the Internet to lay down the lilting, addictive riff on lead single, "Put You in a Song," and never looked back.

"I thought, 'Well, let's explore new sounds, new guitars,' and I think from that a real different, not just a sound, but a different feeling came from this record," Urban said.

He ended up with perhaps his most personal album. The eight-track standard release issued by Capitol Records (there's a

led to 22 deaths in Tennessee and did more than \$2 billion in damage in Nashville alone, luthier Joe Glaser has managed to save some of the most important pieces.

Among them is a 1957 Les Paul Goldtop, worth six figures before Urban bought it and much more now that his name is attached to it. It's a special guitar with an unmatched sound and Glaser realized he was doing more than cleaning and gluing when he reclaimed it.

"It doesn't matter who somebody is," he said. "If they're good at all, their relationship with their instrument is personal and one-on-one. ... Their relationship with their instrument is kind of like their relationship to their dog."

Glaser, who assists in the NasH20 charity that sells some of the stars' damaged instruments to benefit musicians, says he's repaired eight to 10 of Urban's guitars and could keep working on most of the other 50-plus pieces Urban lost if the singer chooses.

Fittingly, the only guitar Urban didn't lose was the one with a lot of personal meaning. That guitar was owned by Waylon Jennings and was a gift from Kidman, who surprised him with it. He wrote two songs on the album with it: "Right on Back to You" and "Georgia Woods."
